Thanks to the 105th Precinct and other city agencies for the efforts in closing smoke shops that were illegally selling marijuana in our community. A big concern for us now is the businesses that were granted licenses to open stores to sell/dispense marijuana and related products. Since Nassau County opted out of this program, it has been observed that these new stores are concentrated in and around Queens Village. We are asking that our elected officials review these locations and ensure that they don't comprise our Quality of Life.

The 105th Precinct is also working with us to stop the escalation of illegal Dollar Cabs on Jamaica Ave.

I'm asking everyone to follow the new laws for proper garbage disposal and the maintenance of their properties. Please help and remind your neighbors.

The migrant shelter at Creedmoor is scheduled to be closed by March 31, 2025. We look forward to returning our community back to a sense of normalcy.

We have heard from several of our community members about the Con Edison rebate program for converting gas boiler heating systems to HVAC electric systems. Many have seen their electric bills increase by hundreds of dollars. Should you consider the conversion from gas to electric for your heating and cooling needs under the Con Edison program, I strongly recommend you do your research to ensure you have a complete understanding of the program and its financial implications.

THE CREEDMOOR HUMANITARIAN EMERGENCY RESPONSE AND RELIEF CENTER

Gov. Hochul announced on February 13 the closing, beginning in mid-March, of the controversial Humanitarian Emergency Response and Relief Center situated on the grounds of the Creedmoor Psychiatric Center in Queens Village. The Governor's Office said it will support the Eastern Queens' community when it comes to public safety, affordability and quality of life issues in a statement. Queens Village Civic thank, our neighboring Civics, our local politicians, especially, City Council Member Linda Lee and State Senator Toby Stavisky, and Queens Community Board 13 for their vocal advocacy against this migrant shelter.

TAX HELP AND E-FILING AT QUEENS PUBLIC LIBRARY

Filing taxes can be an overwhelming, complicated process. But it does not have to be. Queens Public Library is partnering with several organizations to offer FREE tax counseling, preparation and E-filing to New Yorkers whose income is \$84,000 or less.

Free tax preparation is available at the following Queens Library branches:

1. Queens Village: 94-11 217 Street (718) 776-6800).

Currently through April 15, from 1pm - 5pm

2. Bellerose: 250-06 Hillside Avenue (718) 831-8644).

Currently through April 14, from 10:15am - 2pm

You must preregister and schedule an appointment.

REAL ID NEEDED FOR FLIGHTS

Starting on May 7th, Americans must have a REAL ID or a current passport to board a domestic flight. If your New York State driver's license or ID does not have a <u>star</u> or a <u>flag</u> on it, then you do not have a REAL ID-compliant document. You can obtain an enhanced driver's license or ID, which would also allow entry to Canada, Mexico, and some Caribbean countries, at a Department of Motor Vehicle Office or visit dmv.ny.gov to learn more.

CREEDMOOR DEVELOPMENT UPDATE

On March 19 from 6 to 8 pm, there will be another Public Hearing for the Creedmoor Mixed-Use Project via Zoom. The public comment period will close on April 18, 2025, at 5:00 PM. Until then, comments can be sent in writing to ESD,

655 Third Avenue, New York, New York 10017 (Attention: Vanessa Calizaire), or by email to CreedmoorEIS@esd.ny.gov.

In late 2024, the Empire State Development (ESD) released its latest proposed Plan, titled Creedmoor Mixed-Use Project, for developing the Creedmoor Campus.

Highlights of the latest plan, which is similar to its original plan, are:

- 2,775 residential units, 1,526 units will be for ownership and 1,249 for rental.
- The buildings will be 3, 6 and 8 stories.
- The rental units will consist of 393 units reserved for seniors, 428 units for supportive housing and 428 units for affordable housing. Veterans will get preference to 15% of the rental units.
- Land will be reserved for the Dept. of Education for future construction of a K - 8 school.
- Space will be available for small to medium commercial retail businesses. There are also plans for a recreational and a seniors center.

The CB 13 Land Use Subcommittee on Creedmoor and an alliance of the neighboring civics is in support of a 1,000 residential units development, which would mesh better with the community infrastructure and transportation network.

FAIR FARES NYC

Fair Fares NYC is a City program created to help New Yorkers with low incomes manage their transportation costs. Using the Fair Fares NYC MetroCard, eligible New York City residents receive a 50% discount on subway and eligible bus fares. Pay-per-Ride, weekly unlimited, and monthly unlimited options are all available. Fair Fares can also provide 50% off MTA Access-A-Ride paratransit trips. Pay-Per-Ride, 7-Day (Weekly) and 30-Day (Monthly) Unlimited Ride options are all available for those using the Fair Fares MetroCard on subways and eligible buses. Please note Access-A-Ride customers do not use Fair Fares NYC MetroCard; their discount is applied automatically to their Access-A-Ride trips once their Fair Fares and Access-A-Ride accounts are linked.
